## Withdrawal of Recognition of Volleyball Federation of India

Dear Prof. Dr. Achyuta Samanta,

I trust this letter finds you in good health.

On 13 June 2023, the Indian Olympic Association (IOA) provided the attached letter in which it informed the FIVB that it has withdrawn the recognition of the officials of the Volleyball Federation of India (VFI) and has formed an Ad-Hoc Commission to conduct fresh elections.

The FIVB would like to emphasize the FIVB Constitution provides that a National Federation must be recognized by the highest sporting authorities in its country (NOC) as the sole governing body to administer the sport of volleyball in its country. As none of the officials are recognised by the IOA, the FIVB has no choice but to follow their recommendation to organize fresh elections as soon as possible.

It is the FIVB's desire that the work of the Ad-Hoc Committee created by the IOA in which the FIVB also has a representative will finally bring a closure to the governance dispute within the Volleyball Federation of India to allow all of us to focus on growing the sport of volleyball in India.
