### SCHEDULE NOTIFICATION FOR HOLDING ELECTIONTO THE POSTS OF THE EXECUTIVE BODY OF TAEKWONDO FEDERATION OF INDIA FOR THE TERM 2022-26

I have been appointed as the Court Commissioner-cum-Returning Officer for Taekwondo Federation of India (TFI) as per the orders passed by Hon'ble High Court of Delhi on 28.04.2022 in WP (C) No. 11674/2019 to finalise the electoral college of the TFI and to conduct the election to the various posts of the Executive Body of the Federation. In pursuance to the aforesaid orders of the Hon'ble High court of Delhi I have undertaken an elaborate exercise of scrutinizing various documents on the matter & examining the Electoral College prepared by Hon'ble Mr. JusticeR.S.Sodhi (Retd) on 4.5.2016 and the amendments made to it at the time of conduct of the election of TFI in June 2016 under the supervision of Hon'ble Mr. Justice M.L.Mehta. (Retd). While doing so it is noticed that a series of developments have taken place since the conduct of the last elections in June, 2016 such as the incumbents of a number of Member Units have changed, disputes have arisen etc. Therefore, as directed objections/representations were received and decided prior to finalizing the Electoral College and before conducting fresh elections as per the order dated 28.4.2022 of the Hon'ble High Court of Delhi. In doing so, the stakeholders/claimants from the Member Units were given due opportunity to present their case in person and by virtual hearing, submit the documents in support of their claim etc. Each of the Units where there were disputes were heard and their documents were perused and orders have been passed which have been conveyed to the respective parties. The list of Member Units eligible to nominate their candidates for preparation of the voter's list has been prepared and placed on the official website of the Indian Olympic Association (IOA). Separately, these Units have also been informed to nominate their representatives for the Voter's list by the stipulated time.

The Voter's list will be prepared as soon as may be possible after the time stipulated time seeking the names of the representatives from the units is over. The Voter's list will be conveyed to the concerned Units and will also be published on the official website of IOA.

In order to fill up the various posts of the Executive Body of the TFI, a Special General Body Meeting(SGM) of TFI will be held on 14.11.2022 at 11.00 am onwards at the Olympic Bhawan, B-29; Qutub Institutional Area, New Delhi-110016. The only agenda for the meeting is to elect candidates for the various posts of the EB of TFI. No other agenda shall be taken up in the SGM.

The detailed information and timelines for conduct of the elections of the TFI are as under:

#### 2. MANNER OF ELECTION:

- The Elections will be held as per the provisions of the Memorandum of Association of TFI and the guidelines prescribed in the Model Election Guidelines of National Sports Development Code of India, 2011.
- The election shall be held throughsecret ballot only. No proxy voting shall be permitted.
- Every Unit shall be entitled to nominate not more than two names for the Voter's list. Consequently, each Unit will have not more than two votes.
- Each voter shall carry document, having his photo, to prove his identity at the time of the election. The document shall have been issued by any authority of the Central or State Government.
- Duly filled-in Nomination forms in Form No:2 to be physically delivered to the Returning Officer, as detailed under the following Schedule.
- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than one candidate for the same post, either as Proposer or Seconder.
- No person shall be permitted to withdraw his/hername as proposer/seconder, once the nomination paper subscribed him/her has been delivered to the Returning Officer.
- The\_ employees of Central/State government and their undertakings, if any, will be required to obtainNo Objection Certificate (NOC) from their employers and submit the same alongwith the nomination form, if they wish to contest the elections.
