**Important Information Regarding Filing of Nomination**

As notified on 13.06.2023, Nomination papers for the elections to the executive committee of the Wrestling Federation of India are to be held in accordance with its ratified constitution of the WFI and the guidelines of the Ministry of Youth Affairs and Sports, Govt. of India. The nomination papers for contesting on various posts will be received from 28/07/2023, 29/07/2023 & 31/08/2023 from 11:00 am to 5:00 PM, in **Form 2**.

With regard to filing of nominations, following important information/instructions are being given for the facility of the candidates;

1. Nomination can be filed only in person or by authorized representative by physically presenting Form 2 before the Returning Officer from 11.00 AM to 5.00 PM in his Office. Copy of the form 2 is appended below.
2. A proposer or a seconder can propose / second the name of only one candidate for one category of post where number of posts to be filled is one. Similarly, where number of posts to be filled is more than one, proposer / seconder can propose / second names of as many candidates as is the number of posts to be filled and if he/she does so in contravention of the rule, his/her signature on the nomination papers delivered, later in point of time and exceeding the permissible limit, to the RO, and exceeding the permissible limit, shall be deemed to be inoperative.
3. The candidate, his / her proposer & seconder are required to file identification document issued by Govt. authorities having photograph & signature.
4. Candidates should not be disqualified by any clause/provision of the National Sports Development Code of India 2011, and order and the instructions issued by the Ministry of Youth Affairs and Sports, Department of Personnel and Training (DoPT) vide Order No. OM. 11013/1/2016- Estt. A-III dated 05.08.2019 and 27.02.2020.
5. Only those persons can file the nominations, propose / second name(s) of prospective candidate, whose names are included in the Electoral College.
6. Candidates filing their nomination papers will also be required to furnish signed copy of Undertaking / Declaration on the enclosed format, along with the Form 2 which has been prepared based on the instructions of Ministry of Youth Affairs & Sports. The Ministry of

Youth Affairs and Sports, GOI had already clarified, based on the instructions of the DoPT that any government servant will not hold any position in sports body beyond two terms or the time limit of two terms of 5 years each, whichever is earlier. Further, Ministry of Youth Affairs & Sports, vide letter dated 1<sup>st</sup> May 2010, issued instructions relating to age and tenure for office bearers in Executive Committee of National Sports Federations (NSFs).

7. Govt. servants filing nominations will be required to file **“No Objection Certificate” (NOC)** from their employer. In case the said NOC is not available readily at the time of filing nominations, this **could be filed before commencement of scrutiny of nominations i.e. 11.00 A.M of 02.08.2023.**
8. Nomination Forms will be received by the RO/ARO at 4<sup>th</sup> Floor, Room No. 4A Indian Olympic Bhawan, B-29, Qutub Institutional Area, New Delhi-110016 from 28/07/2023 to 29/07/2023 & 31/07/2023, from 11:00 am to 5:00 pm.
9. Nominations can be filed either by the candidates themselves or by their authorized representatives at the aforesaid address. Letter of authorization from the candidate in original will be required to be carried by the authorized representatives for allowing them to submit the candidate’s nomination papers to RO/ARO.
10. Nomination can be withdrawn in **Form 5** from 03/08/2023 to 05/08/2023 from 11.00 AM to 5.00 PM. Form 5 is also appended.
